

## Data Processing Policy

1. The Controller of the personal data is Conotoxia Ltd., a company incorporated and registered in Cyprus with its registered office at Chrysorroiatissis 11, Limassol, Cyprus, conducting business in Poland in the form of a branch of a foreign entrepreneur - Conotoxia Ltd. 3. In order to receive marketing material containing forecasts for 2024, you must consent to be contacted and provided with marketing content by email and telephone. The Controller will process your personal data for the purpose of direct marketing (the legal basis for processing: consent - Article 6(1)(a) of the GDPR, Article 10(2) of the Act on Provision of Electronic Services, Article 172(1) of the Telecommunications Act). By granting your consent to be contacted and provided with marketing content, you consent to processing your personal data for direct marketing purposes.
4. The provision of personal data is voluntary but necessary to receive marketing content. The following personal data will be processed: name, surname, email address and telephone number. Recipients of personal data may be entities that support the Controller's activities (Processors), particularly regarding the provision of ICT solutions used by the Controller.
5. Your personal data may be transferred to third countries (outside the EEA) - e.g. the USA, as we use the IT services of international providers. If we share your data with entities that are outside the EEA, we make sure that these entities provide an adequate level of protection and that the transfer is supported by appropriate safeguards, including but not limited to European Commission adequacy decisions or European Commission standard contractual clauses. 6. Your personal data will be processed and stored for the period necessary to fulfil the purpose stated in paragraph 3, but no longer than 6 months. 7. You have the right to access your personal data and rectify them, erase them (where legally permissible) and limit their processing as well as data portability. Moreover, you have the right to withdraw your consent at any time without affecting the lawfulness of the processing carried out based on consent before its withdrawal.
